Introduction

This directory provides a list of Humana Gold Plus HMO-SNP network providers. To get detailed information about your health care coverage, please see your Evidence of Coverage.

You will have to choose one of our network providers who are listed in this directory to be your Primary Care Provider (PCP). The term "PCP" will be used throughout this directory. Generally, you must get your health care services from your PCP.

How to get the most out of your network

The network providers listed in this directory have agreed to provide you with your health care services. You may go to any of our network providers listed in this directory.

You must use network providers except in emergency or urgent care situations or for out-of-area renal dialysis or other services. If you obtain routine care from out-of-network providers, neither Medicare nor Humana Gold Plus HMO-SNP will be responsible for the costs.

If your plan has providers with preferred cost-sharing as part of its benefits, please refer to the Evidence of Coverage for more information on the cost-sharing for each tier.

What you should do if you have bills from out-of-network providers that you think should be paid by Humana Gold Plus HMO-SNP.

We cover certain health care services that you get from out-of-network providers. These include care for a medical emergency, urgently needed care, renal dialysis (kidney) services that you get when you are outside the plan's service area, care that has been approved in advance by the plan, and any services which were ordered covered through an appeals process. If an out-of-network provider asks you to pay for covered services you get in these situations, please call Customer Care (details on front and back cover). Or send the bill(s) with a note explaining the situation to:

You should never pay any out-of-network provider more than what the provider is allowed by Medicare. Ask the out-of-network provider to bill us first. If you have already paid for the covered services, we will reimburse you for our share of the cost. If you get a bill for the services, you can send the bill to us for payment. We will pay your out-of-network provider for our share of the bill and will let you know the amount, if any, you must pay.

If you have an emergency, we will talk with the doctors who are giving you emergency care to help manage and follow up on your care. The doctors who are giving you emergency care will decide when your condition is stable and the medical emergency is over.

After the emergency is over you are entitled to follow-up care to be sure your condition continues to be stable. Your follow-up care will be covered by our plan. If your emergency care is provided by out-of-network providers, we will try to arrange for network providers to take over your care as soon as your medical condition and the circumstances allow.

Suppose that you are temporarily outside the plan's service area, but still in the United States and territories. If you have an urgent need for care, you probably will not be able to find or get to one of the providers in our plan's network. In this situation (when you are outside the service area and cannot get care from network providers), our plan will cover urgently needed care that you get from any provider.

Our plan does not cover urgently needed care or any other non-emergency care if you receive the care outside of the United States and territories.

If you receive emergency care at an out-of-network hospital and need inpatient care after your emergency condition is stabilized, you must return to a network hospital in order for your care to continue to be covered OR you must have your inpatient care at the out-of-network hospital authorized by the plan and your cost is the cost sharing you would pay at a network hospital.

Getting Care from Specialists

When your PCP thinks that you need specialized treatment, he or she may recommend that you see a network specialist. You do not need a referral from your PCP for covered services from network specialists. For some types of services from plan specialists, you may need to get approval ahead of time from the plan. This is called "prior authorization".

For information on what specialties require a referral or prior authorization, please refer to Chapter 4 of your Evidence of Coverage (EOC).

When choosing a physician for Well Woman exams, please refer to the Specialist section within the provider directory for a listing of OB/GYN physicians.

Mental Health

For mental health or substance abuse services, you or your doctor or counselor should call Humana Behavioral Health for authorization. Please call 1-866-861-4478 (TTY: 1-800-735-2988). The hours are Monday through Thursday, 7 a.m. to 6:30 p.m. CST and Friday from 7 a.m. to 6 p.m. CST. For additional information, go to **Humana.com** or contact the phone number listed on your plan identification card.

Transplant Services

Use of a general service facility for transplant services may result in substantial additional expense to you. For transplant related services, please call 1-866-421-5663 (TTY: 1-800-336-6709). Our hours are Monday through Friday, 8:30 a.m. to 5:00 p.m.

Humana Fitness

Not all Medicare Advantage plans offer a fitness benefit. Please refer to your Evidence of Coverage for fitness benefit information.

Vision Providers

Not all Medicare Advantage plans offer a vision benefit and benefits may vary between plans. Please refer to your Evidence of Coverage for vision benefit information.

Dental Providers

Self-Referrals

In some cases, you can get coverage for the services listed below without a referral or approval ahead of time from your PCP. **"Self-referred"** means you get services on your own from network physicians.

The following services may be self-referred:

- Emergency services, whether you get these services from plan providers or out-of-network providers.
 - Urgently needed care that you get from out-of-network providers when you are temporarily outside the plan's service area.
 - Renal dialysis (kidney) services that you get when you are temporarily outside the plan's service area.
 - You may self-refer to any network provider for covered services.

Hospital Services

The presence of a hospital in this directory does not always guarantee that you will be referred to that particular hospital. Your physician may not admit to all network hospitals. Please consult your current or prospective physician to determine the hospitals with whom they are associated. You may self-refer to a network outpatient hospital. However, inpatient hospital admissions, except in emergency and urgently needed care situations, will require prior authorization from us.

Hospitalist Program

If your PCP participates in the Hospitalist Program, and you are admitted to the hospital, all aspects of your care will be actively directed and coordinated by a full time physician specially trained in inpatient care. The physician is referred to as a hospitalist and is independently contracted and board-certified or eligible for board certification by the American Board of Internal Medicine.

A case management coordinator, another member of the hospitalist team, is a licensed nurse trained in patient care management. He or she coordinates your needs and services (such as lab work, X-rays, consultations and more) with the hospitalist physician.

Your hospitalist physician and case management coordinator will report your condition and progress to your PCP regularly. They may also schedule a follow-up appointment with your PCP.

Network Pharmacies

How to get the most out of your pharmacy network

The "network pharmacies" listed in this directory have agreed to provide you with your prescription coverage. To get a complete description of your prescription coverage, including how to fill your prescriptions, please review the Evidence of Coverage and the Humana Prescription Drug Guide. You may go to any of our network pharmacies listed in this directory. In most cases, your prescriptions are covered under Humana Gold Plus HMO-SNP only if they are filled at a network pharmacy, or through our mail-order pharmacy service. Once you go to one, you are not required to continue going to the same pharmacy to fill your prescription. You can go to any of our network pharmacies. We will fill prescriptions at non-network pharmacies under certain circumstances as described in your Evidence of Coverage.

All network pharmacies may not be listed in this directory. Pharmacies may have been added or removed from the list or changed preferred cost-share status after this directory was printed. This means the pharmacies listed may no longer be in our network, or there may be newer pharmacies in our network that are not listed. Pharmacies listed may also have a different cost-share status. For the most current list, please contact us. Our contact information appears on the front and back cover.

We may also list pharmacies that are in our network but are outside the service area in which you live. You may also fill your prescriptions at these pharmacies. For more information please contact us at the numbers on the front and back cover.

This directory is for the geographic area listed on page 3 which includes the area in which you live. However, we cover a larger service area, and there are more pharmacies where your prescriptions may be covered by our Plan. For information on more pharmacies in our plan network not listed in this directory please see our contact information on the front and back covers.

You can go to all the pharmacies on this list, but your costs for some drugs may be less at pharmacies in this list that offer preferred cost-sharing. We have marked these pharmacies with three asterisks (***) to distinguish them from other pharmacies in our network that offer standard cost-sharing. Not all plans offer preferred cost-sharing. Please refer to your Evidence of Coverage (EOC) for more information.

Medicare Part B prescription drug coverage

Members with only Medicare Part B prescription drug coverage can use the network pharmacies included in this directory to receive their approved Medicare Part B drugs. For more information about receiving Medicare Part B drugs through out-of-network pharmacies, see "Filling prescriptions outside the network" and "How to submit a paper pharmacy claim" beginning on page 12.

Mail-Order Pharmacies

Pharmacies with preferred mail order cost-sharing are pharmacies in Humana's network in which Humana has negotiated lower cost-sharing than at pharmacies with standard mail order cost sharing for its plan members for covered prescription drugs. However, you will still have access to lower drug prices at pharmacies with standard mail-order cost-sharing than at out-of-network mail-order pharmacies. You may go to either of these types of network mail-order pharmacies to receive your covered prescription drugs.

If your plan does not have preferred and standard mail-order cost-sharing pharmacy benefits, you may use any mail-order pharmacy listed.

You can get prescription drugs shipped to your home through our network mail order delivery program. Typically, you should expect to receive your prescription drugs from 5 to 7 days for refills and 7 to 10 days for new prescriptions from the time that the mail order pharmacy receives the order. If you do not receive your prescription drug(s) within this time, please contact Customer Care (details on front and back covers).

To refill your mail order prescriptions, please contact us 14 days before you think the drugs you have on hand will run out to make sure your next order is shipped to you in time.

If you are a member of a qualified State Pharmaceutical Assistance Program, please contact the program to verify that the mail-order pharmacy will coordinate with that program.

Are home infusion pharmacies part of the pharmacy network?

Humana Gold Plus HMO-SNP will cover infusion therapy drugs if:

- Your prescription drug is on your Humana Gold Plus HMO-SNP formulary, or you have a formulary exception;
 - Humana Gold Plus HMO-SNP has approved your prescription drug for home infusion therapy; and
 - Your prescription is written by an authorized prescriber.

Are long-term care pharmacies part of the pharmacy network?

Residents of a long-term care facility may access their prescription drugs covered under Humana Gold Plus HMO-SNP through the facility's long-term care pharmacy or another network long-term care pharmacy.

Are Indian Health Service/Tribal/Urban Indian Health Program (I/T/U) Pharmacies part of the pharmacy network?

Only Native Americans and Alaska Natives have access to Indian Health Service/Tribal/Urban Indian Health Program (I/T/U) Pharmacies through Humana Gold Plus HMO-SNP pharmacy network. Those other than Native Americans and Alaskan Natives may be able to access these pharmacies under limited circumstances (e.g. emergencies).

What are Physician Dispensing Pharmacies?

These are Physicians/Clinics that are part of Humana's pharmacy networks that can dispense prescribed medications from within their office.

Filling prescriptions outside the network

Generally, we only cover drugs filled at an out-of-network pharmacy in limited, non-routine circumstances when a network pharmacy is not available. **Before you fill your prescription in these situations, call Customer Care (details on front and back cover) to see if there is a network pharmacy in your area where you can fill your prescription.** If you do go to an out-of-network pharmacy, you may have to pay the full cost (rather than paying just your copayment) when you fill your prescription. You can ask us to reimburse you for our share of the cost by submitting a claim form.

However, even after we reimburse you for our share of the cost, you may pay more for a drug purchased at an out-of-network pharmacy because the out-of-network pharmacy's price is generally higher than what a network pharmacy would have charged. You should submit a claim to us if you fill a prescription at an out-of-network pharmacy as any amount you pay will help you qualify for catastrophic coverage. To learn how to submit a paper claim, please refer to "How to submit a paper pharmacy claim" below.

We cannot pay for any prescriptions that are filled by pharmacies outside of the United States and territories, even for a medical emergency.

How to submit a paper pharmacy claim

When you go to a network pharmacy your claim is automatically submitted to us by the pharmacy. However, if you go to an out-of-network pharmacy, the pharmacy may not be able to submit the claim directly to us. When that happens, you may need to pay the full cost of your prescription. When you return home, simply submit your paper claim and your itemized receipt to the following address:

Introducción

Este directorio proporciona una lista de los proveedores de la red de Humana Gold Plus HMO-SNP. Para obtener información detallada acerca de sus cobertura de cuidado de la salud, consulte su Evidencia de cobertura.

Tendrá que elegir a uno de los proveedores de nuestra red que estén en este directorio como su proveedor de cuidado primario (PCP). El término "PCP" se utilizará bastante en este directorio. Por lo general, usted deberá recibir sus servicios de cuidado de la salud a través de su PCP.

Cómo aprovechar al máximo su red

Los proveedores de la red que están en este directorio han aceptado proporcionarle sus servicios de cuidado de la salud. Puede visitar a cualquiera de los proveedores de nuestra red que están en este directorio.

Debe utilizar los proveedores de la red excepto en casos de emergencia o cuidado de urgencia o para diálisis renal u otros servicios fuera del área. Si usted utiliza proveedores fuera de la red para su cuidado de rutina, ni Medicare ni Humana Gold Plus HMO-SNP serán responsables por los costos.

Si su plan tiene proveedores con costo compartido preferido como parte de los beneficios, consulte la Evidencia de cobertura para más información sobre el costo compartido de cada nivel.

Qué debe hacer en caso de recibir facturas de proveedores fuera de la red y que usted cree que deberían ser canceladas por Humana Gold Plus HMO-SNP.

Nosotros cubrimos ciertos servicios de cuidado de la salud que usted reciba de proveedores fuera de la red. Entre estos se encuentran cuidado que usted reciba en una emergencia médica, cuidado que se necesite con urgencia, servicios de diálisis renal (riñón) que usted reciba fuera del área de servicio del plan, cuidado que haya sido aprobado con anticipación por el plan, y servicios cuya cobertura haya sido ordenada a través de un proceso de apelación. Si un proveedor fuera de la red le pide pagar por servicios cubiertos que usted reciba en alguno de estos casos, llame al departamento de Atención al Cliente (consulte la información detallada en la portada y la parte de atrás). O envíe la(s) factura(s) con una nota explicando la situación a:

Usted nunca deberá pagar a ningún proveedor fuera de la red más de la cantidad permitida por Medicare. Pídale al proveedor fuera de la red que antes nos envíe una factura. Si usted ya pagó por los servicios cubiertos, nosotros le reembolsaremos la parte que nos corresponde del costo. Si usted recibe una factura por los servicios, nos la puede enviar para que nosotros la paguemos. Nosotros le pagaremos al proveedor fuera de la red la parte que nos corresponde de la factura y le informaremos a usted la cantidad que debe pagar, en caso de que sea necesario.

Si tiene una emergencia, nosotros hablaremos con los médicos que le están proporcionando el cuidado de emergencia para ayudar a manejar y hacer el seguimiento de su cuidado. Los médicos que le están proporcionando el cuidado de emergencia decidirán cuándo su estado es estable y que la emergencia médica ha terminado.

Después de que la emergencia haya terminado usted tiene derecho a recibir cuidado de control posterior para asegurarse de que su estado continúe estable. Nuestro plan cubrirá su cuidado de control posterior. Si su cuidado de emergencia es proporcionada por proveedores fuera de la red, nosotros intentaremos coordinar para que proveedores de la red se encarguen de su cuidado tan pronto como lo permitan las circunstancias y su afección médica.

Supongamos que usted se encuentra temporalmente fuera del área de servicio del plan, pero dentro de los Estados Unidos o sus territorios. Si necesita cuidado de urgencia, es posible que no pueda encontrar o conseguir a uno de los proveedores de la red de nuestro plan. En este caso (cuando usted se encuentra fuera del área de servicio y no puede obtener cuidado de proveedores de la red), nuestro plan cubrirá el cuidado médico que se necesita con urgencia que usted reciba de cualquier proveedor.

Nuestro plan no cubre cuidado médico que se necesita con urgencia ni ningún otro cuidado que no sea de emergencia si usted lo recibe fuera de los Estados Unidos o sus territorios.

Si usted recibe cuidado de emergencia en un hospital fuera de la red y necesita cuidado como paciente interno después de que su afección de emergencia se estabiliza, debe regresar a un hospital de la red para que su cuidado continúe estando cubierta O debe recibir su cuidado como paciente interno en el hospital fuera de la red autorizado por el plan y su costo es el costo compartido que usted pagaría en un hospital de la red.

Obtener cuidado de especialistas

Cuando su PCP cree que usted necesita tratamiento especializado, él o ella podrá recomendar que vea a un especialista de la red. No necesita un referido de su PCP para servicios cubiertos de especialistas de la red. Para ciertos tipos de servicios de especialistas del plan, es posible que necesite obtener una aprobación del plan con anticipación. Esto se llama "autorización previa".

Para obtener información sobre las especialidades que requieren un referido o autorización previa, consulte el Capítulo 4 de la Evidencia de cobertura (EOC, por sus siglas en inglés).

Al elegir a un médico para los exámenes para el bienestar femenino, consulte la sección de Especialistas en el directorio de proveedores para obtener una lista de Obstetras/Ginecólogos.

Salud mental

Para los servicios de salud mental o de tratamiento de abusos de sustancias, usted o su médico o asesor debe llamar a Humana Behavioral Health para la autorización. El horario es de lunes a jueves de 7 a.m. a 6:30 p.m., hora estándar de la zona central, y los viernes de 7 a.m. a 6 p.m., hora estándar de la zona central. Autorreferidos

Los siguientes servicios pueden ser de autorreferido:

- Servicios de emergencia, independientemente de si los recibe de proveedores del plan o de proveedores fuera de la red.
 - Cuidado que se necesita con urgencia que usted reciba de proveedores fuera de la red cuando se encuentra temporalmente fuera del área de servicio del plan.
 - Servicios de diálisis renal (riñón) que usted recibe cuando se encuentra temporalmente fuera del área de servicio del plan.
 - Usted puede autorreferirse a cualquier proveedor de la red para recibir servicios cubiertos.

Servicios hospitalarios

La presencia de hospitales en este directorio no siempre garantiza que usted será referido a un hospital en particular. Es posible que su médico no conceda admisiones a todos los hospitales de la red para las hospitalizaciones. Consulte a su médico actual o potencial para determinar los hospitales con quienes él/ella está asociado. Usted puede autorreferirse a un hospital ambulatorio de la red. No obstante, las hospitalizaciones como paciente interno, salvo en casos de emergencia o de cuidado que se necesita con urgencia, requerirán nuestra autorización previa.

Programa de hospitalistas

Si su PCP participa en el Programa de hospitalistas, y usted es admitido al hospital, todos los aspectos de su cuidado serán dirigidos y coordinados activamente por un médico de tiempo completo especialmente capacitado para cuidado de hospitalización. El médico se conoce como hospitalista y es contratado de manera independiente y tiene certificación en su especialidad o reúne los requisitos necesarios para su certificación por la Junta Americana de Medicina Interna.

Un coordinador de administración de casos, otro miembro del equipo de hospitalistas, es un/a enfermero/a con licencia capacitado/a en la administración de cuidado de pacientes. Él o ella coordina todas las necesidades y los servicios (como los análisis de laboratorio, radiografías, consultas y mucho más) con el médico hospitalista.

Su médico hospitalista y coordinador de administración de casos darán informes regulares sobre su estado y progreso a su PCP. También podrán programar una cita de control posterior con su PCP.
