


# MediKids vaccines billing and service guidelines

Humana is committed to providing MediKids vaccines to children and ensuring we have the mechanisms in place for the most efficient billing and payment for you. The following information details Humana’s guidance related to this integral service.

Question	Response
How should Humana be billed and how will providers be reimbursed?	<p>Physicians should bill the appropriate vaccine and administration code(s) when these services are rendered to children 1 to 4 years old.</p> <p>The vaccine reimbursement rates (which apply to appropriately billed services for children in the MediKids population) are included on the final page of this document.</p>
How can I determine MediKids coverage?	<p><b>You can determine if the patient is covered by MediKids in two ways:</b></p> <ol style="list-style-type: none"> <li>1. When looking up the patient in the Florida Medicaid Managed Information System (FLMMIS) provider portal, “MK” Medicaid codes identify the member as a MediKids member.</li> <li>2. How much will Humana reimburse for the vaccine?	Humana will reimburse the vaccines at the rates listed for each <b>vaccine CPT code</b> on the final page of this document.
Will I be reimbursed for vaccine administration?	<p>The vaccine administration's reimbursement will be at the rates defined on <a href="#">AHCA's MPIP site</a> for the corresponding year.</p> <p><b>Note:</b> Providers who have qualified for MPIP as well as those not qualified on the MPIP program will receive payment for the vaccine code and vaccine administrations.</p>
