Drug recall notice for tetracycline

Avet Pharmaceuticals has voluntarily recalled tetracycline due to test results that indicated the medicine may provide less than the expected amount of tetracycline to the body to fight infection.¹ Tetracycline is used to treat infections including upper and lower respiratory infections and skin and soft tissues infections. For patients with compromised immune systems and the elderly, who may be taking tetracycline to treat a serious infection such as pneumonia, there is a risk that if there is not enough tetracycline in the body to fight the infection, this could result in rapid worsening of the infection.

Please carefully review the medicine below and talk to your doctor about it right away.

What this means for you:

- If you take tetracycline, talk to your doctor or healthcare provider about switching to another medicine or obtaining the same medicine that is not part of the recall.
- It is important that you do not abruptly stop taking your medication. Contact your doctor to discuss safe discontinuation of tetracycline.
- To determine if a specific product has been recalled, patients should look at the drug name and company name on the label of their prescription. If the information is not on the bottle, patients should contact the pharmacy that dispensed the medicine.
