

COVID-19 vaccine update: December 9, 2021 information regarding Medicare vaccines

Beginning Jan. 1, 2022, Humana will reimburse the administration fee(s) set forth in the COVID-19 Administration Fee Table for Medicare Advantage (MA), Medicare Advantage Prescription Drug (MAPD) and Illinois dual-demonstration plan members, per guidance released from the Centers for Medicare & Medicaid Services. Claims for Medicare prescription drug plan members should be submitted to the member's Part B Medicare Administrative Contractor (MAC) or their MA-only plan, as applicable.

To receive payment of administration fees, pharmacies must submit the claims with the NCPDP fields populated as shown in the following table:

Note: This submission information is for COVID-19 vaccines that are provided to pharmacies at no cost. Humana will provide revised submission information when/if COVID-19 vaccines are available for purchase directly by pharmacies or providers.

Humana will pay eligible pharmacies administration fees, as set forth in the COVID-19 Administration Fee Table below, for administering COVID-19 vaccines to Humana Medicare members.
