

Drug Recall for Guanfacine Extended-Release (ER) Tablets

As you may know, The U.S. Food and Drug Administration (FDA) has announced that Apotex Corp is voluntarily recalling three (3) lots of Guanfacine ER 2 mg tablets, prescribed for the treatment of Attention Deficit Hyperactivity Disorder (ADHD).

Apotex Corp made this decision due to trace amounts of Quetiapine Fumarate in one lot of Guanfacine ER 2 mg tablets. Quetiapine is prescribed for Schizophrenia and other mental disorders. Taking this medication instead of Guanfacine could result in the possibility of hypersensitivity reaction and may potentially have additive effects in lowering blood pressure, sleepiness/sedation, and dizziness. To date, Apotex Corp has not received any reports of adverse events related to this recall.

What this means for you:

- It is important that patients do not abruptly stop taking their medication. Patients should contact their doctor or healthcare provider to discuss switching to another medicine or obtaining the same medicine that is not part of the recall.
- To determine if your medicine is affected, you should look at the drug name and company name on the label of your prescription. If the information is not on the bottle, you should contact the pharmacy that dispensed the medicine.
