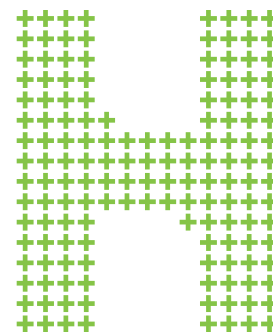


# We'll help pay your over-the-counter items

## **Over-the-Counter card is loaded with a \$350 allowance every three months for OTC purchases**

The Over-the-Counter (OTC) card gives you a quarterly allowance to spend on approved OTC items—like digestive aids, first-aid products and more. It makes the things you need to support your health more affordable.

### **Use the card—and save**

You can use your OTC card to buy many over-the-counter items through Humana's mail-order pharmacy and on-the-spot at other participating locations. You'll receive more information about participating locations when your card arrives.

### **Start every quarter with a \$350 allowance to spend**

Spend it at participating locations or lose what you don't spend by the end of the quarter. You keep the same card quarter to quarter—you start each quarter with a reload of your \$350 OTC allowance. Funds will not roll over at the end of the plan year, so you must use all funds by the end of the year or they will expire.



### **Your OTC card is included with your plan**

Your Humana OTC allowance is built into your plan benefits and costs you nothing extra. If you have an OTC card, keep using it. If you are a new member and don't have it yet, we'll send your card to you in December to use starting in January. You will need to activate your new card before using it. We look forward to caring for you.
