

Drug Recall for Ruzurgi® 10 mg tablets

As you may know, Jacobus Pharmaceutical Company Inc., the manufacturer of Ruzurgi® (amifampridine) 10 mg tablets, is voluntarily recalling three (3) lots of this drug, which is prescribed as treatment for Lambert Eaton Syndrome (LEMS). The drugs are being recalled because they were found to be contaminated with yeast, mold, and aerobic bacteria. Patients with LEMS who receive these drugs may have an increased risk for serious and life-threatening infections, due to their underlying condition.

The recalled drugs are identified by certain national drug codes (NDCs) and lot numbers.

What this means for you:

- It is important that you do not abruptly stop taking your medication. Talk to your doctor or healthcare provider about switching to another medicine or obtaining the same medicine that is not part of the recall.
- To determine if your medicine is affected, you should look at the drug name and company name on the label of your prescription. If the information is not on the bottle, you should contact the pharmacy that dispensed the medicine.
