

Drug Recall for Coppertone SPF 50 Spray Products

Coppertone, owned by Beiersdorf, is voluntarily recalling specific lots of five Coppertone aerosol sunscreen spray products: Pure & Simple Baby SPF 50 spray, Pure & Simple Kids SPF 50 spray, Pure & Simple SPF 50 spray, Sport Mineral SPF 50 spray, and Travel-Size Sport Spray SPF 50. Coppertone SPF 50 sprays are used to protect the skin against sunburns and prevent skin cancer. Coppertone decided to recall these drugs due to the presence of Benzene in these products.

Due to Benzene being classified as a carcinogen to humans, there are multiple possible side effects. Depending on duration and level of exposure, it can increase risk of cancers including leukemia, and blood cancer of the bone marrow and blood disorders which can be life threatening. However, daily exposure to benzene at the levels detected in these affected Coppertone aerosol sunscreen spray products would not be expected to cause adverse health consequences. To date, Bayer has no known reports of adverse events related to this recall.

What this means for you:

- To determine if your medicine is affected, you should look at the drug name and company name on the label of your prescription. If the information is not on the bottle, you should contact the pharmacy that dispensed the medicine.
