

Drug Recall for Lidocaine HCl Topical Solution 4%

As Teligent Pharma, Inc., a company that makes Lidocaine HCl Topical Solution 4%, 50 mL screw cap glass bottles is voluntarily recalling five (5) lots of this drug that is prescribed as a topical anesthetic. The drugs are being recalled because they are super potent, which could lead to higher than intended doses.

Patients who receive these drugs may develop local anesthetic systemic toxicity, depending on the duration of the treatment and the specific patient. Local anesthetic systemic toxicity can result in central nervous system reactions, including excitation and/or depression and more serious signs of cardiovascular toxicity, such as bradycardia, hypotension, and even cardiovascular collapse can present very quickly. To date, Teligent Pharma, Inc. has not received any reports of adverse events related to this recall.

The recalled drugs are identified by certain national drug codes (NDCs) and lot numbers.

What this means for you:
