Visit	Codes
Initial Preventive Physical Examination (IPPE) for FQHCs	G0468 (FQHC visit code, IPPE or Annual Wellness Visit) with G0402
Annual Wellness Visit for FQHCs	G0468 (FQHC visit code, IPPE or Annual Wellness Visit) with G0438 (initial Annual Wellness Visit), G0439 (subsequent Annual Wellness Visit)
Annual Preventive Physical Exam for FQHCs	99381-99387 (New patient), 99391-99397 (established patient) FQHCs should submit claims for this service on a CMS-1500 with place of service code 50.
Well Woman Exam for FQHCs	G0466 (FQHC new patient) with Q0091 and/or G0101, G0467 (FQHC established patient) with Q0091 and/or G0101
Problem-oriented evaluation and management (E/M) service for FQHCs	G0466 (FQHC new patient) with problem-oriented E/M code, G0467 (FQHC established patient) with problem-oriented E/M code

Initial Preventive Physical Exam (IPPE)

- Known as Welcome to Medicare preventive visit
- Allowed only within first 12 months after effective date of Medicare Part B coverage
- One-time benefit covered by Humana Medicare Advantage (MA) plans
- Submit claims on a CMS-1450 form, or electronic equivalent, with revenue code 052X.
- Report G0468 (FQHC visit) and G0402

Annual Wellness Visit

- Initial Annual Wellness Visit allowed once per lifetime after first 12 months of Medicare enrollment (cannot be in same calendar year as IPPE)
- Subsequent Annual Wellness Visit allowed once per calendar year after initial Annual Wellness Visit
- Humana allows one Annual Wellness Visit per calendar year (Jan.-Dec.).
- Submit claims on a CMS-1450 form, or electronic equivalent, with revenue code 052X.
- Report G0468 (FQHC visit), along with G0438 (initial Annual Wellness Visit) or G0439 (subsequent Annual Wellness Visit).

Annual Preventive Physical Exam

- Humana MA benefit, not covered by Original Medicare
- Physician or other healthcare provider reports service on a CMS-1500 form, or electronic equivalent, with CMS place of service code 50.
- Report:
 - New patient, one from the range of 99381 to 99387, or
 - Established patient, one from the range of 99391 to 99397
- Humana covers one Annual Preventive Physical Exam per calendar year (Jan.-Dec.).



Well Woman Exam

- Covered once every 24 months, the same as Original Medicare
 - Exceptions: Allowed once every 12 months for women at high risk for cervical cancer and for women of child-bearing age who have had an exam in past three years that indicated abnormalities
- Submit claims on a CMS-1450 form, or electronic equivalent, with revenue code 052X
- Well Woman Exams should be submitted with codes Q0091 and/or G0101
 - New patient, report HCPCS G0466 (FQHC visit), along with CPT codes Q0091 and/or G0101
 - Established patient, report HCPCS G0467 (FQHC visit), along with CPT codes Q0091 and/or G0101

Billing Tips

- An Annual Wellness Visit and Annual Preventive Physical Exam can be performed during the same visit.
 - The FQHC reports Annual Wellness Visit, not Annual Preventive Physical Exam
 - Physician or other healthcare provider reports Annual Preventive Physical Exam on a CMS-1500, with CMS POS 50 (Federally Qualified Health Center)
- A problem-oriented evaluation and management (E/M) service can be performed during the same visit as an Annual Wellness Visit or Annual Preventive Physical Exam
 - Submit the Annual Wellness Visit or Annual Preventive Physical Exam as you normally would
 - Submit the problem-oriented E/M service:
 - When performed with Annual Wellness Visit Report FQHC visit G0466 (initial) or G0467 (subsequent) and the E/M service with modifier 59 and submit claim on a CMS-1450 or the electronic equivalent with revenue code 052X
 - When performed with Annual Preventive Physical Exam Report FQHC visit G0466 (initial) or G0467 (subsequent) and the E/M service with modifier 59 and submit claim on a CMS-1450 or the electronic equivalent with revenue code 052X
