\* The **Household Discount (HHD)** is a discount for Humana Medicare Supplement policyholders sharing the same residential address. Both must be Humana Medicare Supplement policyholders. **Washington state defines this as a Spousal Discount.** There is a section on the application titled “Discount Determination,” that requires an applicant to provide the name and Medicare claim number of the individual living at their current address in order to qualify for this discount. Note: The Household Discount will be removed if the qualifying Medicare Supplement policyholder moves and no longer shares a resident address with the eligible policyholder or they terminate their Humana Medicare Supplement policy. If the qualifying policyholder becomes deceased, the discount will still apply. A “Household” is defined as a condominium unit, a single family home, or an apartment unit within an apartment complex.

\*\* The **Enhanced Household Discount (EHHD)** is a discount for Humana Medicare Supplement policyholders who reside with a spouse (including civil union/domestic partner) or have continuously resided with at least one, but no more than three adults in the past 12 months. For the purpose of this discount, a civil union partner or domestic partner will be considered a legal spouse when such partnerships are valid and recognized in your state of residence. We may request additional documentation to determine eligibility.
