

Drug Recall for Vancomycin Hydrochloride for Oral Solution USP, 250mg/5mL

On March 27, 2024, the U.S. Food and Drug Administration (FDA) announced that Amneal Pharmaceuticals, LLC. Is voluntarily recalling four (4) lots of Vancomycin Hydrochloride for Oral Solution USP, 250mg/5mL, at the consumer level. The company is initiating this recall due to the potential for some bottles to have dosing above the maximum daily dose allowance, which may be harmful. Please carefully review the impacted medication and talk to your doctor about it right away.

What this means to you:

- To date, the pharmaceutical company has not received any adverse event reports related to this recall.
- Talk to your doctor or healthcare provider about switching to another medication or obtaining the same medication that is not part of the recall.
- To determine if your medication is affected, you should look at the drug name and company name on the label of your prescription. If the information is not on the bottle, you should contact the pharmacy that dispensed the medication.
