# Humana's Consolidated EEO-1 Report

- The following Consolidated EEO-1 Report reflects a comprehensive breakdown of the workforce (by race, ethnicity and gender) that Humana is required to submit annually to the U.S. Equal Employment Opportunity Commission (EEOC). Readers should keep in mind the following when reviewing the EEO-1 Reports:
  - EEO-1 Reports require employers to aggregate data on hundreds of job titles into just 10 broad job categories. We have determined that Humana's workforce falls within eight out of the ten job categories, whereby we exclude "craft workers" and "laborers and helpers" from relevancy.
  - The data points presented in the following EEO-1 Report are raw numbers. We have presented the data in accordance with the required EEO-1 reporting framework and do not intend for the data to serve any other purpose. Further, we caution readers against construing, interpreting or otherwise applying the data in any manner contrary to how it's been presented.
  - Data included in each year's report reflects company internal data as of the last pay period of the calendar year.
- 2. An analysis of Ethnic Minorities\* during 2021, in the eight job categories applicable to Humana, showed a 2% increase in three categories: Executive/Sr. Officials & Managers, Sales Workers, and Administrative Support. Representation in three categories (First/Mid Officials & Managers, Professionals, and Operatives) was unchanged. There was a 1% decrease in

two categories: Technicians and Service Workers. Overall Minority workforce representation remained the same at 43%.

3. An analysis of the representation of Women during 2021 showed an increase in seven of the eight job categories applicable to Humana. Increases ranged from one to three percent, with a 3% increase in the Executive/Sr. Officials & Managers category. There was no change in representation in Professionals. The total representation of Women in the workforce increased from 71 to 72%.
