- **LRR-2022-COM-5827854** - The Centers for Medicare and Medicaid Services (CMS) issued the updated interest rate from the Department of the Treasury regarding overpayments and underpayments by the Medicare program. The rate is 9.375% effective April 18, 2022. The previous rate was 9.125% for the period of January 18, 2022, through April 17, 2022.

- **LRR-2022-MCD-5826218** - The Illinois Department of Healthcare and Family Services (HFS) issued an email on April 13, 2022, to provide clarification regarding billing for SUPR services rendered via a telehealth modality.

“During the extent of the COVID-19 Public Health Emergency, services rendered by a licensed SUPR (PT 075) provider may be delivered via telehealth. At this time, SUPR providers are not required to utilize telehealth specific modifiers (GT, 93) or places of service (02, 10), when submitting telehealth claims for reimbursement. However, HFS is aware of some providers who have elected to begin utilizing telehealth specific coding (GT or 93 modifier, place of service 02 or 10) on their claims. Health Plans should not reject or deny claims from SUPR providers solely for the use of the GT/93 modifier or 02/10 place of service.”

- **LRR-2022-MCD-5826854** - The Illinois Department of Healthcare and Family Services (HFS) issued a notice to announce coverage of a team-based model of mental health care that addresses trauma recovery from chronic exposure to firearm violence for Medicaid eligible children and adults in which services will be covered under both Medicaid fee-for-service and Medicaid managed care organization plans effective for dates of service on or after May 1, 2022.
